Immigration to Australia - Ascertaining all Ancestral Arrivals

A pedigree¹ in which forty ancestral immigrants feature, as the fabric from which our family has been tailored, is a microcosmic account of Australian immigration as a whole. It spans 111 years and four Australian States and Colonies. Assisted, unassisted and bounty passengers, as well as convicts, crew-members and one exile are represented. It includes single males, single females, married couples, some with children and extended families, with varying levels of education. Births and deaths at sea, shipboard romances resulting in Colonial marriages, an application for the passage of a convict's family, desertion, reunions and a solitary return to the homeland are also involved. The nineteenth century immigrants originate from England and Scotland, and a twentieth century Italian migrant rounds out the pedigree. Confusion with names on passenger lists has enforced the location of alternative documentation to ensure accurate identification. Many research avenues have been scrutinised in order to ascertain the vessel, arrival date and place of origin for each immigrant ancestor, thus sifting out any "swimmers".

The research into this particular pedigree began, as should all nineteenth century immigration investigations, with the assisted arrivals. The Public Record Office Victoria has an index to assisted immigration, now also available on microfiche. Initially this index revealed that Isaac and Sarah PRIMMER and their three children, John H, 10, James, 9 and Harriet, 2, departed from Southampton on 3 October 1856 on the *Balnaguith* and disembarked at Belfast on 17 January 1857.²

Robert and Mary Ann SURKITT and their sons, George and William, arrived at Portland on board the *Helen* on 12 November 1852.³

There are entries for two men named Alexander DUNCAN,⁴ however a surviving letter dated 20 December 1856, written shortly after his arrival and returned to Australia by his younger brother,⁵ indicated that he landed at Belfast per the *Euphrates* on 19 November 1856 and was employed by A C KELL,⁶ a farmer, whose daughter he would eventually marry.⁷

The aforesaid Andrew Kell, and his bride Sarah, had arrived as bounty passengers per the *England* on 17 July 1841.⁸ Andrew's brother, John, was on board the same ship in the single men's quarters.⁹ Andrew and Sarah's surname was recorded as Kill. Andrew's parents and younger siblings who, according to family legend, emigrated with them, were not located at this time.

William and Eliza BURCOMBE accompanied by daughter, Martha, brought a handwritten copy of their Evercreech marriage certificate¹¹ on the *Annie Wilson* which docked in Melbourne before sailing on to Belfast and landing there on 18 January 1859.¹²

William SCRIVENS, a shepherd, sailed on the *Marion*, one of nine ships to bring exiles to Port Phillip in the 1840s,¹³ arriving on 25 January 1848.¹⁴ The nominal list detailed his ten-year sentence for sheep stealing and imprisonment at Millbank.¹⁵ The Surgeon's Journal described his bout of fever and treatment on board.¹⁶

Exiles were not supervised like convicts, but were unable to return to their homeland until the expiration of their original sentence.¹⁷

Also noted at the same time, and awaiting further research before claiming, were single men John CARMODY, a blacksmith of "Edinboro" arriving on the *Cheapside* on 18 August 1848¹⁸ and Quenten DICK who arrived on the famed *David Clark*, ¹⁹ the first ship to bring immigrants directly from Great Britain to the Port Phillip District of NSW. It docked on 27 October 1839.²⁰

Subsequent research would prove these men belonged to the PRIMMER pedigree, both meeting their prospective brides on the voyage. Quintin DICK married Agness EDGAR²¹ in Melbourne²² as soon as his original 3 month term of engagement in the country had expired.²³ John CARMODY was in fact a blacksmith,²⁴ and married shipmate Margaret McARTHUR,²⁵ recorded as Margaret McKester. She was positively identified by her age, place of origin and the fact that she was employed by her uncle Peter,²⁶ a well-to-do squatter who left her an annuity in his will.²⁷ Further research would be needed to positively identify other arrivals.

Meanwhile, moving on to the Unassisted Passenger lists. The parents of Sarah KELL, Robert and Agnes SHEARER, and two of their adult daughters, Elizabeth, 27, and Janet, 22, arrived on board the *Cheviot* on 13 September 1854. Robert and Agnes, both in their sixties, lowered their ages by ten years, seemingly to comply with regulations governing requirements for immigrants.

William and Elizabeth McKenzie also arrived as unassisted passengers. They sailed on board the *Thames* arriving in Geelong in May 1857 and are recorded as Mr & Mrs McKenzie, both aged 22.³² It can be deduced that, as they married in Scotland on 22 January 1857³³ and their eldest daughter, Jane, was born at Barwon on 18 December 1857,³⁴ they arrived in between those dates. The ages and nationalities given corroborate these findings.³⁵

James McLelland³⁶ and the Archives Office of NSW have published some handy guides to early Victorian immigration,³⁷ and a perusal of these can assist in solving some naming problems, such as the discovery of Edward and Margaret CARROLL and their three children on the *England* in 1841.³⁸ Could this be the Edward and Margaret Kell who were meant to have arrived on that ship with their sons and daughter-in-law?

Certainly the beginning, middle and last sounds of both names could easily be confused when spoken and, once transcribed, remain alphabetically estranged. Other details of ages, place of origin and children's names fit known information, with the exception of James aged 4 being recorded as John.³⁹ Edward and Margaret KELL were documented in baptismal⁴⁰ and land records⁴¹ in the 1840s. Edward, a shoemaker, returned to Scotland alone and was living with a woman in Rothesay in 1851, 42 and died there in 1867. 43

In an attempt to track down the remaining arrivals, alternate spellings were explored, working on the theory that if KELL could be recorded as "KILL", then WELLS may be listed under WILLS or WALLS. A theory well worth following up, as a likely family was discovered under the name of WALLS, with all other information bearing out the previously known data. James C and Mary WALLS and their daughters, Jane, Agnes and Wilhelmina from Dumfries arrived on the Garland on 31 July 1852. 44 Their son, James U WALLS, died at sea and is documented in the List of Deaths. 45 A check of Black's Surnames of Scotland explained that in Dumfriesshire, the pronunciation is WALLS. 46

Two other families were subsequently found in the Victorian assisted immigration indexes, following the discovery that Jessie May BRILL's parents, William and Rachel, 47 had changed their names. William turned out to be James LITCHFIELD⁴⁸ who had arrived from Cambridge aged 9 on the *America* with his father, John, 38, stepmother Ann, 21 and sister, Elizabeth, 12.⁴⁹ John's second wife Ann gave birth to a son on board ship and his birth is recorded on the passenger list⁵⁰ and registered in the marine births.⁵¹ Fourteen year old Joseph LITCHFIELD emigrated with his family, but was in the single men's quarters.⁵² Rachel's name was actually Rachel BATTY⁵³ and her parents, Abraham and Martha BATTY, arrived at Geelong on 8 November 1848 on the Andromache with their young family, Kezia, Charlotte, Dawson Wilson and Jemima.⁵⁴

The Victorian branch of the Australian Archives Office holds records of passenger arrivals and departures at Port Melbourne 1924-1968.⁵⁵ A search of these lists (not indexed) showed Fiorano FERRI arrived in Melbourne on the *Caprera* on 1 February 1925.⁵⁶ Searches for foreign arrivals are aided by naturalization documents which usually give the date, place and ship of arrival, as in the case of F FERRI. 57 These should be consulted before conducting unnecessarily laboriously long searches into unindexed material.

Moving interstate to South Australia, where a search of the index to assisted immigration revealed the arrival of the HOWARD family of Northampton on board the Magdalena on 26 August 1853. Brothers Alfred HOWARD, 35, and Christopher HOWARD, 31, were accompanied by their respective wives, Elizabeth and

Priscilla, and families, Ruth, 11, Sarah, 8, Mary Ann, 5 and infant Elizabeth and Elizabeth, 8, John, 5, and Charles, 1.58 Thomas LIVERTON of SA did not appear on this index.

Tasmania was the destination for several earlier ancestral arrivals. The parents of Elizabeth TAPSELL both arrived in Hobart. Her mother, Jane SWIFT, a widow, ⁵⁹ was transported for seven years, arriving on the *Mary* (3) on 5 October 1823. ⁶⁰ Jane married James TAPSELL, ⁶¹ a crew-member of the *Regalia* which arrived on 30 November 1819.⁶²⁶³ He made several trips as a steward on this ship between Hobart and Sydney.⁶⁴ James and Jane's only child, Elizabeth, 65 married John JONES. 66 The permission to marry records at the Archives Office of Tasmania defines John's arrival on board the cholera-ravaged⁶⁷ Katherine Stewart Forbes⁶⁸⁶⁹ on 16 July 1832, being transported for fourteen years. 70 He changed his name to John WALKER in 1846 at the expiration of his sentence⁷¹ and changed it again to George MOORE when he moved to Victoria.⁷²

Convict James LAMBERT arrived in Hobart on the Asia V (Agar) on 7 December 1827⁷³. Due to good behaviour, he was able to apply to have his wife, Elizabeth, and five children, Maria, 18, Mary Ann, 16, James, 12, George, 7 and Jane, 5, of Motcombe, Dorset, sent out to join him. ⁷⁴ His wife and four of the five children did indeed emigrate, Maria the eldest being the exception.⁷⁵ They are recorded as Elizabeth LAMBERT and four children and were given passage on the female convict ship Mary (3) on its voyage to Hobart arriving on 19 October 1831.76

Another convict, David JONES' arrival was traced through a document discovered at the LDS Family History Centre which listed Convict Records in Tasmania 1804-1841.⁷⁷ The entry for David Jones showed two separate convictions, one in Launceston on 12 March 1835 and one twenty-two years earlier in 1813⁷⁸ for which he was transported to Sydney on board the typhus-stricken⁷⁹ Surrey (1) which arrived on 28 July 1814, 80 then removed to the Derwent on board the *Emu*, arriving at George Town on 30 July 1815. 81 This record confirmed that David JONES, a carpenter of Campbell Town in the 1830s had, 8283 in fact, been transported two decades earlier.

This left just two ancestors to track down. Mary Ann ROTHERY who, despite searches under alternate spellings defied all attempts to be traced in Victoria where she married, ⁸⁴ lived ⁸⁵ and died. ⁸⁶ However, the release of the Biographical Index of South Australians noted her presence in a small entry ⁸⁷ taken from the Adelaide Hospital Admissions. ⁸⁸ A check of the assisted immigration index located her arrival in Adelaide on the *Harry Lorrequer* on 26 December 1849. ⁸⁹

Thomas LIVERTON's arrival was ascertained following contact with a distant relative in Devon, England⁹⁰ who recounted the tale of his departure from home, as told to her by an elderly relative, Ruby BIDGOOD, who had heard this story as a young child from her grandfather, John LIVERTON, brother of Thomas. One day Tom LIVERTON came across the local parson riding on horseback; they met in a gateway and the parson ordered him to open the gate. Tom replied that he would open it if the parson said 'please' in a civil manner. This so enraged the parson he hit Tom with his riding crop, and Tom pulled him off his horse and thrashed him. When Tom went home and told his mother, she was so terrified for his life that they went to Barnstaple where he signed on as an able-bodied seaman on the *Star of Peace* just leaving for Australia.⁹¹ On arrival he jumped ship and walked up into the Adelaide Hills.⁹² The Archives Office in South Australia was able to confirm that Thomas LIVERTON had deserted from the *Star of Peace* which docked in Adelaide on 14 July 1857.⁹³

These immigrant ancestors to Australia faced all the challenges encountered by their contemporaries, long journeys in less than ideal conditions, enduring the sometimes tedious, sometimes treacherous journey to the other side of the world, to pioneer a young country in an endeavour to improve the way of life for themselves, their children and ultimately their grateful descendants.
